DISABLED COUNSELING AND COORDINATION UNIT REPORT These studies are ongoing or completed in 2022-2023.

- 1. All blocks have elevators for disabled personnel, students and visitors.
- They have access to all floors. There is also an additional keypad in the elevators for the visually impaired.
 There are reliefs in Braille alphabet (Block A and F). Work continues on other blocks.
- Wheelchair users at the entrance of all buildings and in places where there is a level difference at the building entrances Ramps for people have been completed.
- 4. Libraries in all blocks are accessible by elevator.
- 5. The library entrance is of suitable width and size for disabled people.
- To assist disabled students or staff who want to take books from the upper shelves in the library An employee is assigned to the library during working hours.
- 7. "Emergency light alarm systems" have been installed in all blocks for the hearing impaired.
- 8. Disabled toilets have been built in EGKHIJ blocks. However, work continues in ABC Blocks.
- A portable ramp has been provided in the conference halls for physically disabled people to access the stage.
 Depending on the activity, transportation to the relevant area is provided in advance.
- 10. Exams for disabled students will be held in a separate area, accompanied by an invigilator, depending on the student's disability. is provided.
- 11. For visually impaired students, large print question papers are used in exams.
- Access of disabled students, employees and visitors to canteens, dining halls and other social areas mostly provided. It is planned to eliminate the deficiencies.
- Disabled students were asked for their ideas and opinions about the problems they experienced. more accordingly Events are organized for awareness
- 14. Health conditions were taken into account when distributing tasks for three disabled personnel.

Ongoing Studies:

- 1. Renovation works of disabled ramps at building entrances that are not built in accordance with the standards continues.
- 2. Suitable areas have been discovered for buildings that do not have disabled toilets and the work is continuing.
- Necessary surveys have been made to eliminate the deficiencies in emergency buttons in existing disabled toilets.
 Efforts are being made to obtain it.
- 4. Regarding the size of information desks in libraries that are accessible to disabled people studies are continuing.
- In order for people with physical disabilities and wheelchair users to listen to lectures comfortably, the first rows should be placed in the first rows.
 Work continues to make it suitable for use.
- From the companies regarding the use of Braille Alphabet on the voice warning system and keypads inside the elevators.
 Price offers are collected. Studies continue.
- 7. For visually impaired people to access all classrooms and social areas inside and outside the building. Price quotes are collected from relevant companies for embossed flooring application. From this stage Afterwards, it will be implemented in other buildings, especially the Rectorate Building (Block A).
- To accompany or assist disabled staff and students during periods of possible natural disasters.
 It is planned to appoint person and persons.

Planned Works:

- 1. Regarding physical accessibility;
 - Necessary procedures have been planned in all buildings in accordance with the relevant provisions of the Disabled Persons Law No. 5378. and has been started. In addition; 3194 zoning law and the directives published in accordance with these laws and TS 9111 (in buildings for disabled people and people with limited mobility) as indicated by the regulations. accessibility requirements) and TS ISO 23599-13536 (auxiliary products for the visually impaired or low vision tactile walking surface markings) were taken into account.
- 2. It is planned to install warning and guiding floor coverings and signs.
- 3. Eliminating the lack of disabled toilets in all buildings and campuses of IGU

planned.

- 4. Risk-preventing elements (application of anti-slip tape on stairs, handrails, railings, etc.) in accordance with the relevant law It is planned to be rebuilt with the missing parts in accordance with standard dimensions.
- 5. It is planned to re-examine the existing disabled toilets to make them comply with the standards.
- 6. It is planned to create an emergency call button in disabled toilets.
- 7. It is planned to make all elevators suitable for the use of visually impaired people. (Braille alphabet elevator birds used, audible warnings in elevators, etc.).

- 8. It is planned to hang floor plans created from Braille alphabet on the floors for the visually impaired.
- Identifying places within the building that are inaccessible to people with walking disabilities and taking necessary precautions was planned to be acquired.
- It is planned to identify deficiencies in order for disabled people to reach all social areas. Shortcomings
 Once determined, a work plan is planned to be created.
- 11. In the landscaping of all buildings of Istanbul GelisimUniversity, inappropriate places on ramps should be eliminated. renovation, pavement-related defects and road crossing inconveniences (lack of pedestrian paths, (no traffic lights, etc.) must be requested from the relevant units.
- 12. The shuttles operating as rings between the Metrobus and the school are not suitable for use by disabled people. It is planned to make these services suitable for the use of disabled people.
- 13. It is planned that floor plans for the visually impaired will be made in Braille alphabet and hung at the entrances.
- 14. A barrier-free university provides individuals and all segments of society with the physical, social, cultural,

- is one of the elements. Individuals with disabilities can exercise their rights to higher education fully, effectively and equally. To build barrier-free universities together, department by department, faculty by faculty, campus by campus. We aim.
- 15. During periods of possible natural disasters, ID cards of disabled personnel and students must be changed to elevator codes and It is planned to make improvements for reading ID cards.

Considering that the education is online, we can meet our disabled students individually. and face-to-face interviews could not be held. For these reasons, regarding our disabled students and staff, The work program was renewed.
