APPLICATION DATES

Applications for the students who would like to benefit from the 2025 Project Year Erasmus+ Study Mobility will be accepted **ONLINE** through the TURNA **PORTAL** https://turnaportal.ua.gov.tr/) between 19 February 2025 and 10 March 2025. With the online application, the necessary documents must be uploaded to the system and then the application willbe completed. Applications of students who do not upload the required documents to the system or make incomplete/false statements in the application will be deemed invalid. Before applying, it is important to read the 2024 Project Year Erasmus+ Study Mobility Application Guide. Please read the Online Application Guide on our website regarding the application system.

ERASMUS+ LANGUAGE EXAM

Erasmus+ Foreign Language Exam will be held between **18-20 March 2025** by Istanbul Gelisim University Foreign Languages School. The written part of the exam will be held on **18 March 2025**. The speaking part of the exam will be held on **20 March 2025**. Exam times will be announced on the IGU School of Foreign Languages website.. Students who score 19 points or less on the written exam will not be assigned for speaking exam. Do not forget to take your student cards with you when you take the exam.

The exam consists of 2 parts: The test and speaking. The test section contains multiple-choice questions in 3 parts: grammar, vocabulary, and reading. Students are required to take the speaking test after the Testsection. If both parts (test and speaking) are not completed, your exam will be invalid.

You can access sample exam questions from the link https://ydyo.gelisim.edu.tr/tr/akademik-icerik-ornek-sinavlar. In order to be successful in the Erasmus+ Foreign Language exam, you must have at least 60 points from the relevant exam. Students who declare that they will take the Foreign Language Exam but do not take it will be deducted -5 points in their next application.

NOTE: YDS, YÖKDİL, and international exams accepted as equivalent by ÖSYM are also accepted. During the application, you will need to upload documents proving that you have obtained at least 60 out of 100 from the relevant exams. Students who upload the relevant document will be exempt from the Erasmus+ Foreign Language Exam.

IMPORTANT NOTES

- * Students who are entitled to receive a grant within the framework of **Erasmus+ Study Mobility** can only receive a grant for one semester (maximum 6 months).
- * 60 ECTS for one full academic year of students benefiting from <u>Erasmus+ Study Mobility</u>; 30 ECTS credits for one semester in a two-semester academic year and 20 ECTS credits for one semester in a three-semester academic year are expected to be sent to follow the program. Students in the master's and doctoral thesis period are required to document this credit load in the form of thesis work.
- * Erasmus+ Study and Internship Mobility can be done for a total of 12 months at each education level (first level: associate degree, undergraduate; second level: master's degree; third level: doctorate, specialization in medicine). The total mobility period (study + internship) at each level with or without a grant cannot exceed 12 months.

Applications for **Erasmus+ Study Mobility** are received once a year for the next academic year. Our students who will apply for Erasmus+ Study Mobility must choose the countries and universities they would like to go to during the application. Our students are required to examine the <u>Erasmus+ Bilateral Agreements List</u>, which includes the universities with that our departments have agreements. During the application, the list of universities with which the student has a contract regarding his/her departmentwill appear as an option.

In the case of applying to both **Erasmus Study and Erasmus Internship Mobility** at the same time, a -10 deduction will be made. If a student who has not benefited from mobility before applies for both study and internship mobilities at the same time, it is left to the student's choice in which mobility "-10 points" deduction will be applied. In this case, the students should specify which mobility they prefer as their first choice from the option in the online application form. -10 points will be applied to their second choice. If a student has previously benefited from mobility and applies for both study and internship at the same time, a deduction of "-10" points is applied for the type of mobility that they used before and "-20" points for the second type of mobility the applied for.

WHO CAN APPLY?

- 1. Students participating in the mobility must be full-time students. Formal Education (1st and 2nd Education) Associate, Undergraduate and Postgraduate students, and at least 1st-year students at Istanbul Gelisim University can apply for study and/or internship mobility.
- 2. A student enrolled in a Double Major/Minor Program can apply from only one major.
- 3. Those who have carried out the Erasmus+ mobility activity at the same and/or previous education level can apply. However, it should not be forgotten that Erasmus+ study and internship mobility can be carried out for a total of 12 months at each education level.
- 4. Students who have not renewed their registration in the relevant academic year and students who have frozen their registration can apply, but cannot participate in the mobility.

WHO CAN NOT APPLY?

- 1. Students of English Preparatory, Scientific Preparation, Open, and Distance Education Programs, and special students can not apply for Erasmus+ Study and Internship Mobility.
- 2. Final-year students can not apply for Erasmus+ Study Mobility.
- 3. Students can not apply from the minor program.
- 4. Students who continue their education at our University with any exchange program cannot apply.
- 5. Graduate students can not apply for study mobility.
 - 6. Students enrolled in doctoral programs can not benefit from exchange programs at the following stages:
 - a) For doctoral students who have not taken the doctoral qualifying exam, in the last semester for which the doctoral qualifying exam must be taken,
 - b) In the last semester in which the thesis proposal defense must be entered,
 - c) If there is a term restriction that will prevent "at least 3 successful thesis follow-up periods" among the doctoral graduation requirements,
 - d) In the last semester of the maximum duration of the program.
- 7. Students enrolled in Master's programs with thesis cannot benefit from exchange programs at the followir stages:
 - a) In the thesis stage and in the period when they are entitled to take their thesis defense,
 - b) In the last semester of the maximum duration of the program
 - 8. Non-Thesis Master's Students can not benefit from Erasmus+ Study Mobility.

ERASMUS+ STUDY MOBILITY APPLICATION CONDITIONS

- 1- The student must be an active student enrolled in a higher education program at any of the formal education levels (Associate Degree, Undergraduate, Postgraduate) within the higher education institution.
- 2- a) For Undergraduate/Associate Degree students' GPA of at least 2.20/4.00
 - b) For master's and doctorate students the GPA must be at least 3.00/4.00

Students who do not meet these criteria can not apply. The student's unsuccessful course(s) are not an obstacle to the Erasmus+ study and internship mobility application.

- 3- Having a sufficient number of courses for study mobility (30 ECTS per semester)
 For graduate and doctoral students who do not have a course load, for example, who are in the thesis period, a learning agreement can be arranged for 30 ECTS non-course workloads in one academic term.
- 4- Within the current education level, the sum of the period of benefiting from higher education mobility activities during the Erasmus+ and Lifelong Learning (LLP) period and the period of study and internship that he/she will benefit from does not exceed 12 months.

5- To get at least 60 points out of 100 from the Erasmus+ Foreign Language Exam¹ (In order for the student with the criteria and base points to be considered successful, the Erasmus+ Program Grand Total Score must be 60/100)

Except for the foreign language grade, students who meet the above-mentioned requirements will be able to apply at the first stage.

ATTENTION!

Candidates are required to check their education information and current academic average information over the data on the e-Devlet and application portal system. Candidates are personally responsible for the updated and accuracy of the relevant information. If an application is made with incomplete or incorrect information, the application will be deemed invalid.

EVALUATION CRITERIA

In the evaluation; 50% of the General Weighted Grade Point Average (GPA) and 50% of the Foreign Language Score are taken. The sum of these scores forms the final score (Erasmus+ Grand Total Score). In order for the student whose criteria and base points are met to be considered successful, the Erasmus+ Program Grand Total Score must be 60/100.

Selection criteria and weighted scores to be used in evaluating applications:

Placements made are final in terms of Erasmus+ Study mobility; however, it is a pre-selection in terms of grant distribution. The announced quotas are estimated, and the students who are placed in line with the quotas based on the Erasmus+ Grand Total Score will be in the status of "Candidate student" until the grant allocation is finalized.

Students who were selected in the previous year and could not be sent due to lack of grant and/or quota or other reasons cannot be sent directly to the next year by transferring them as an "earned right". They are evaluated and selected by providing all the necessary conditions for selection separately for each contract period.

QUOTAS

Students are ranked according to the Erasmus+ Grand Total score and placed according to the order of preference and the quota of the universities. Grant allocation within the scope of the KA-131 project for the 2025 project year has not been realized yet. Therefore, the grant quotas are also unknown. However, in order to use the project time efficiently, it has been decided to distribute the Erasmus+ Student Mobility Estimated quota on the basis of the number of Faculty/School/Institute students on the basis of faculties/schools/institutes, taking into account the quota for the 2024 project year. In addition, in order to ensure a fair and transparent distribution between English and Turkish departments within the faculty, a distribution was made by considering the number of English and Turkish departments.

In line with the grants to be allocated by the Turkish National Agency, the number of Erasmus+ Study Mobility quotas for the 2025 Project year may be less or more than the estimated quotas. For this reason, whether all students in the original list will receive a grant will be finalized after the Turkish National Agency grant allocation. Students who remain on the reserve list can participate in the mobility without a grant within the quotas of the universities we have contracted with.

MONTHLY GRANT PAYMENT ACCORDING TO THE COUNTRIES

The students in the main list are given the grant to help with the additional expenses arising from being abroad during their activity period abroad. Grants are only contributions and not intended to cover all of the students' activity-related expenses. A student can waive financial support. Countries where student mobility activities can be carried out are divided into 3 groups according to their standard of living and monthly/daily education and internship grants are determined for country groups. Country groups and monthly/daily grant amounts to be given to students going to these countries are given in the table below:

ADDITIONAL GRANT SUPPORT IN STUDENT MOBILITY

Additional grant support will be provided to participants with limited opportunities in addition to the grant they deserve. In addition for the grant in question to be granted, a participant with limited means is defined as an individual with limited economic and social opportunities and who fits into the following subcategories.

- 1) Those who are subject to Law No. 2828 (Those who have a protection, care or shelter decision by the Ministry of Family and Social Services pursuant to Law No. 2828)
- 2) Students for whom protection, care or accommodation decision has been taken within the scope of Child Protection Law No. 5395
- 3) Those who have no other parent's income and receive an orphan/death pension
- 4) Children of martyrs/veterans and veterans themselves
- 5) Those who are granted a pension for themselves or their families (the student, their parents or guardians), who prove that they have received financial support from municipalities, public institutions and organizations (Ministry, Social Assistance and Solidarity Foundations, General Directorate of Foundations, Kızılay, AFAD) at the time of their Erasmus application. It is sufficient to submit a document.)
- 6) Disabled people⁶
- 7) Students who have one of their parents or their guardians, who are over 65, and who receive disability or needy pension within the scope of Law No. 2022, dated 01.07.1976 on the Pension Funding of the Needy, Powerless and Orphaned Turkish Citizens and the Disabled and Needy Turkish Citizens⁷
- 8) Those whom themselves or their first-degree relatives receive aid from AFAD.

The following amounts of Additional Grant Support are provided to students who meet the above scope, upon their request and on condition that they document their situation, depending on the type of mobility:

Inclusion Support

Erasmus+ Program encourages the participation of people with special needs in the program. A person with special needs is a potential participant whose personal physical condition, mental state or health condition does not allow them to participate in the project/mobility activity unless there is additional financial support. Additional grant requests can be made within the contract period, but in any case, up to 60 days before the end of the contract. (For details, see 2024 Contract Term Erasmus Implementation Handbook)

TRAVEL SUPPORT AND GREEN TRAVEL

In order to contribute to the travel expenses of students, travel support is provided for study and internship mobility. The km value between two points from the student's place of residence to the place of activity is determined by means of the distance calculator and the travel grant is calculated using the table below. The grant equivalent of the kilometres in the distance band calculator in the table below is the round-trip figure, and the amount in question is not multiplied by two.

Green travel is travelling by using public transport with low carbon emissions. The use of buses, trains and shared cars are included in the scope of green travel. In order to receive green travel support, green travel must be used on departure and return and more than half of the entire journey must be made using green vehicles. If necessary, individual support grants can be awarded for travel time before and after the activity, with a maximum of two days for travel days and a maximum of six days if green travel is used.

- Please do not apply before reading the 2024 Project Year Erasmus+ Study Mobility Application Guide and the text of the announcement.
- Applications of students who would like to benefit from the 2024 Project Year Erasmus+ Study Mobility will be received **ONLINE** through the TURNA PORTAL system (https://turnaportal.ua.gov.tr/) between **19 February 2025 and 10 March 2025**. After the specified date, no application or document entry will be made into the system.
- You have to enter the application system with your e-devlet password.
- In the Foreign Language Information section, if you do not have a valid foreign language document (such as YÖKDİL, YDS, etc.), select the "I want to take the university language exam" tab.
- In the Contact Information section, please report your current e-mail address that you actively use. Our Office cannot be held responsible for any problems that may occur during the process due to an error in the e-mail statement.
- Please check your application form in the confirmation section. If there is no missing or wrong click on the "Complete the application" tab. Only completed applications can be seen by our Office.
- Please make sure that you have uploaded all the necessary documents, the application form and your approved up-to-date transcript as PDF to the system.
- In order to avoid any problems in the future, when choosing a university, please pay attention to points such as the application dates of the other university, the desired language level and course compatibility with the department, and the visa processes of the preferred country.
- Students should contact the Erasmus Department Coordinators regarding all questions regarding academic issues (choosing a university, matching courses, taking courses from above or below).
- You can send an e-mail to erasmus@gelisim.edu.tr regarding the technical problems you experience with the applications.
- Applications will end on 10 March 2025. Please do not leave your application until the last minute.
- Application Steps are included in the annex of the advertisement published in Turkish and English.
