Consent for Collection and Use of Personal Information

Name, address, phone number, mobile phone number, e-mail, additional contact information, school information (final education division, Name of university in school, department information, grade etc.), resident registration number (for foreign residents and foreigners in the case of foreign residents and applicants: alien registration number or passport number)

Purpose of collection and use of personal information:

- Personal information is used to accept applications for exchange students

Retention and use period of collected personal information:

- After achievement of processing purpose and when the information becomes unnecessary, all personal information will be destroyed immediately.
